The FOCUS Foundation is a 501 (c)3 non-profit organization which has established goals in the following areas:

- · Granting funds to educators who spend money out of their pockets
- Encouraging students to read
- Presenting financial literacy topics to various groups in the community

Partnering with the Sports & Wellness Program to promote wellness & diabetes education to the youth

The Foundation was formed in 2007 and since that time there has been over \$303,632 granted to educators in our community. Children and education are the passion of the Foundation.

The word FOCUS spelled out equals "For Our Children's Ultimate Success".

Where do the funds come from?

All of the FOCUS Foundation funds come from fundraisers with our staff and Board of Directors volunteering their time, efforts and suggestions.

Starting in 2022, the committees determined a different direction was necessary. There will be two main events – Kids Fest and a Trunk or Treat Event. Both events are "free" and open to the community. There are vendor sponsors for both events also.

There are other fundraisers throughout the year to continue to raise funds for our special cause. Some of these include: Candy Sales, Dress Down, Casual Dress Days and our annual Raffle.

Other fundraisers throughout the year that continue to raise funds for our special cause include:

• Helping Hands – which is a program that is supported by the staff at CoastLife Credit Union. Staff donate a set amount per pay period and those funds go to the FOCUS Foundation. For the year 2023, the FOCUS Foundation donated \$3,513.00.

• Raffle – this is always a great fundraiser for the FOCUS Foundation. For the year 2023, the raffle sales brought in \$6,784.39 in donated funds.

Where do the funds go?

The funds are disbursed in grant forms to educators who show a need for an expense for their school or their students, playground equipment, library books and more. During 2023, we granted over \$30,898 back to the schools in our six-county area.

The FOCUS Foundation supported the 5k Run hosted by the Corpus Christi Education Foundation in January 2023 – this run was well attended with over 1,500 runners participating.

What other programs are under the FOCUS Foundation umbrella?

Leadership Academy

The Leadership Academy continued its second year in 2023 providing credit union industry and leadership education to 22 aspiring leaders from 4 credit unions. The classes met from April to December for 5 hours a month. They reviewed two leadership books – Turn This Ship Around and Everyone Communicates but Few Connect. The graduation was held during the December Coastal Bend Chapter of Credit Union dinner at Kiko's Restaurant.

The Right Start Program (Formerly the Summer Sports and Wellness Program)

In 2014, the FOCUS Foundation was approached to partner with the Summer Sports and Wellness Program. A partnership directed by Raul Munoz, a Preferred Partner of CoastLife Credit Union and TAMUCC Department of Kinesiology.

The program, typically, provides fitness activities, nutritional education, strategies for developing healthier lifestyles including financial literacy and diabetes education for prevention and mitigation. In addition, participants were exposed to a fun, caring and nutruring university environment. This program provides this great opportunity to approximately 125 low-income students in the Nueces County area. Initially this was a federally funded program, but that funding was discontinued a few years ago. Hence, our program has become dependent on outside sources. The TAMU-CC Department of Kinesiology continues to host the program in their facilities. However, due to university policy as it relates to programs funded through outside entities, support was channeled through another non-profit organization. Hence, the partnership with the FOCUS Foundation.

2023 Highlights

- Our summer program provided 197 students in the Coastal Bend with academic instruction, skills training, and competition in a variety of activities designed to improve student's "Quality of Life."
- Expanding our program to Texas A&M University Kingsville
 - o First year of programming included:
 - 15 Days
 - 72 students enrolled with 88% of them attending daily.
 - Boys and Girls ages 9-14
- Joint research between the Kinesiology Department at both universities.
 - o The purpose was to track the benefits of physical activity throughout our program.
 - o Pre/Post Test Results (data upon request)
 - o One student lost 12 pounds from the TAMUCC location. (19 days)
